

Buckmore Park Scout Campsite – Archery Activity Instructions and Risk Assessment

Activity Instructions

Introduction

Archery is a popular activity at Buckmore Park Scout Campsite (BPSC). We have an outdoor archery range which is available all year round. Equipment and instructors can be arranged, however pre-booking is essential. Our archery staff are all trained to the appropriate standard for visiting groups. The archery range distance is up to 30 metres. The range has three bosses, so groups shoot three at a time with the rest of the group waiting behind a safety line. We have tabs & braces for everyone to wear & we have some left handed bows. Please try to spread out any left handed members of your group so that they don't all end up in one group.

The following paragraphs detail the plans and safety measures in place at BPSC which ensure that all age groups participating in archery at BPSC can understand the risks involved with the activity, how they have been mitigated and can enjoy the activity safely.

At the time of writing the BPSC Activity Manager for Archery is vacant.

Responsibilities of Session Leaders (whether provided by BPSC or by a visiting group):

Group Size

 A Session Leader should not supervise more than 12 participants and there must be at least one other adult present to supervise those group members not shooting at the time.

Preparation and Equipment

 Instructions, sent out at the time of booking, detail what is appropriate clothing for the activity. Participants must wear long sleeved tops which aren't loose. Closed footwear must be worn on the archery range – NO FLIP FLOPS OR OPEN-TOED FOOTWEAR IS ALLOWED. Any jewellery or watches must be removed from participants arms, any loose upper clothing must be tucked in and long hair tied back.

Briefing

Safety is of paramount importance in all the activities & each activity will include a safety talk for each group. This will be kept as brief as possible, but must take place. For the safety of our staff & the rest of your group, messing about or repeated disregard of safety will result in activities being stopped. The safety talk will cover the following points

- Outline of the format of archery session.
- Archery rules
- Please switch mobile phones OFF or onto SILENT & DO NOT use them while participating in archery.
- Participants must be at least 8 years old to take part in this activity (Beaver scouts and Rainbow guides are excluded from this age restriction).
- Please ensure that you wear long sleeved tops which aren't loose.
- Please ensure that you are wearing closed footwear in the archery range NO FLIP FLOPS OR OPEN-TOED FOOTWEAR IS ALLOWED.
- Please remove any jewellery or watches from your arms and ensure loose upper clothing is tucked in and long hair is tied back.
- It is advised visitors carry out their own risk assessment taking into account the age, experience and needs of their own group.
- Copies of our risk assessments for activities are available to download from the website.
- Please be aware that for safety reasons, activities may have to be called off at the last minute due to bad weather.
- Procedures in event of accident.
- Welfare check/medical conditions.

Pre-existing conditions

 The session leader must make themselves aware of any participants suffering from Asthma, Epilepsy, severe allergies or any other relevant medical condition and ensure that prescribed medication is available if required. Medication is to be carried by the adult with the participating group with the individual in suitable proximity.

Weather

• Due to the nature of the outdoor range at Buckmore Park, the weather had a

significant impact on the safe conduct of archery sessions. If the Session Leader believes it is unsafe to continue the session will be abandoned.

Conduct of Session

- The Session Leader will prepare the equipment, ideally before the group arrives getting the equipment from the store.
- The Session Leader will check the range for safety.
- The Session Leader will greet the group and give the briefing (described above).
- The archery session will be delivered in a safe manner as dictate by formal training instruction.
- At the end of the session the Session Leader will collect all equipment and notify the Activity Manager of any issues with the equipment.
- All equipment locked away.

Planning & Reporting

- All incidents, accidents, near misses and hazards must be reported using appropriate forms.
- Deflects and damages must be reported.
- Any safety concerns arising from the session must be reported to the Activity Manager.

		Any person(s) nearby either fence line looking down the range the activity must be STOPPED IMMEDIATELY	Session Leader
		Safety command explained and reinforced throughout the session – "fast" or "stop" to be used.	Session Leader
		Arrows only to be touched following the command "Fire When Ready" or "load".	Session Leader
		No one to load their bow until they are standing astride the firing line	Session Leader
		Once a participant has shot all three arrows they are to sit down on the bench or retire from the firing line and await further instructions.	Session Leader
		No one is to distract a person when they are in the act of loading an arrow or shooting.	Session Leader
		Those not shooting arrows should all be sitting and waiting quietly	Session Leader

Hit by falling target	All Participating in Activity	Participants to place their hand on the target prior to pulling out the arrow to anchor the target.	Session Leader

		Difficult to reach or deeply embedded arrows to be withdrawn by staff only.	
Hit by an arrow when collecting shot arrows	Those collecting arrows	If more than one participant is shooting at a target only one collects their arrows at a time. Staff to organise when each participant approaches the target.	Session Leader

Strained joints	All Participating in Activity	Bows with appropriate draw strengths to be used for Participants	Session Leader
Sore fingers	All Participating in Activity	Finger tabs not currently available. (this will be looked at and reviewed throughout this coming season)	Session Leader
Hit by bow string	All Participating in Activity	Arm guards on the inner forearm of the hand holding the bow are available for all participants if required	Session Leader
Impact of Minor Cuts and abrasions due to shooting the arrows	All Participating in Activity	Qualified First Aider should be present throughout the activity	Session Leader
